
A TRUSTED RESOURCE

WQA's American National Standards Institute (ANSI) accredited laboratory offers rigorous testing for product certification. Ensuring products safety and efficacy is vital in providing safe drinking water to all.

- The Gold Seal Program is the oldest third-party testing and certification program in the water treatment industry. Our program certifies drinking water treatment products to internationally-recognized standards.
- The WQA Sustainability Certification Program is the first of its kind in the drinking water treatment industry. The Sustainability Certification Mark verifies for retailers and consumers that a product has been manufactured according to industry standards for recognized best practices in environmental sustainability and corporate social.
